

# A Harmonious Duet: Music and Art Therapy Lift Spirits

Creativity unfurls as residents bend over canvases, their brushes guided by the medley of classical music filling the air.

This isn't a typical art class. It's a unique program blending music and art therapy, bringing joy and a sense of purpose to residents of the Wasserman Residence.

The guiding hand behind the pairing of classical music with art workshops, creating an environment that aids residents' emotional well-being, belongs to Anni Tran, Hebrew Home of Greater Washington activities director. Held 10 times in 2023, the workshops were made possible by contributions to CESLC's Guardian Fund.

Joey Mánlapaz leads the sessions. A contemporary realist painter whose works are widely recognized, she serves on the associate faculty of the Corcoran School of Art & Design and is a lecturer at The Art League. "It's beautiful to see residents hold a paintbrush and express themselves freely. Their creations inspire me by their zest for life," she says.

"The music isn't just background music to create art. It also allows residents who might not be participating in the art to still enjoy the session and experience the positive effects of music therapy and being part of the community," says Tran.

"I needed something to keep me occupied," resident Mavis Cantrill says. "I'm not much of an artist but in the art workshop, you can take a plain piece of paper and draw on it or paint on it and create a joyful piece." Despite physical limitations, she finds solace and expression through the vibrant colors and positive messages she paints onto canvas.

Her room, in fact, reflects this newfound passion, adorned with her artwork mixed with family photos and a collage of affirmations that serve as a daily reminder to "enjoy your day" and "dwell in the positive."

The innovative program, Tran adds, serves as a testament to the fact creative expression has the power to uplift spirits, foster connections and spark joy regardless of age or ability.

# Newspaper Builds Community One Article at a Time

There's a different type of newspaper making headlines at Revitz House: The Revitz Review. This monthly resident-run publication doesn't offer the latest news but builds connections.

At heart, the publication "transforms strangers into friends," as one Revitz House resident describes it, serving as a reminder that even in a place where "everybody comes from somewhere else," a sense of belonging can blossom.

Editor-in-Chief Beverly Marmon embodies the publication's spirit. A stage 3 kidney-cancer survivor, she found a new chapter in life at Revitz House, where she's lived since 2018. The residential community is "different things to different people, but you can choose your attitude."

She chose positivity, an emotion that guides The Revitz Review.

The Review fosters new connections by showcasing residents' stories and talents and sharing experiences from informative articles to humorous anecdotes.

"Initially I wanted something to do, and I didn't want it to be a temporary thing," says Marmon. "I think The Review is successful because the residents contribute. We have some residents that

send in entries monthly and, of course, we have birthdays, which are very important."

With four grandchildren and three great grandchildren, she knows how important personal and family milestones can be. Her son is a pediatric surgeon and her daughter an executive at a talent management company.

"Several years ago, one of the residents came to me and she said 'I have no family and several people have wished me a happy birthday. Had my birthday not been in The Revitz Review, no one would have known it was my birthday and it would have been just another day.' I knew then the paper was worth it!"

The Revitz Review's impact is profound, says Diane Stern, Revitz House executive director. "It's given residents a sense of belonging. They learn from and support each other, forging a true community."

Cathy Tricquet, Revitz House life and leisure manager, lauds Marmon's dedication. "She encourages everyone to contribute. It's hard work, but with Beverly, it doesn't feel like it! The paper is a testament to shared stories and a positive outlook."

# Performing Arts Class Adds Joy to Life

Watching her fellow Ring House residents perform comedy skits reminded 90-year-old Elaine Schwartzbach that, despite age, "life goes on for everyone and that all the good traits are still there, intelligence and knowledge. When you get older—it doesn't all end then."

The skits were part of a program partnership between Charles E. Smith Life Communities and Theater J, a Washington-based nationally known professional theater that celebrates and explores the Jewish experience and the universal human condition. In 2023, the collaborative effort provided three courses for Ring House residents: "Making a scene with a partner," "Finding your voice: storytelling journey," and "Funny business: How comedy works."

"I like to try everything," said Schwartzbach, a lifelong theater enthusiast and Ring House resident for more than three years. "I liked the subjects. Each instructor was very good. The quality was outstanding."

The comedy training was especially enjoyable for both residents and instructors. "Let's be honest; they're all comedians," says instructor Holly Twyford. "The interesting thing was that the class morphed into something else, and I sort of just went with it."

As the class turned into an exploration of Jewish influence on American comedy, she left one day with "homework" to study comedians suggested by class participants. "I want to do what they want to do," she says, "and if you walk in with an agenda that is a little too rigid, it's not going to work. You want people to have fun—and we were all having a ball."

The award-nominated Twyford has performed in close to 80 theater productions including Arena Stage, Shakespeare Theater, Studio Theatre and Signature Theatre. She is a Lunt-Fontanne Fellow, a member of the Studio Theatre's Cabinet and a Ford's Theatre Associate Artist.

Adapting that way "takes a special kind of teacher," says Schwartzbach. "They understand how to keep our world expanding." She credits the theater class as one of several Ring House programs that help her to maintain her independence. "You just have to push a little harder and then you find people more like you. Taking chances—it's just a joy!"
